APPROVE INTENT TO FILL REQUEST FOR EXECUTIVE DIRECTOR POSITION:

Ms. Franks stated that all the Board Members should have received a copy of the letter Staff proposed to send to the Office of Personnel Management regarding Mr. Baird's resignation and notifying them that APERS will be advertising to fill this position as soon as possible.

Ms. Lea motioned to approve the letter and was seconded by Mr. Brady. Motion passed.

APPROVE JOB DESCRIPTION & CLOSE DATE FOR JOB POSTING:

Ms. Franks said that the Trustees had been given a copy of the job description for the Executive Director's position. She proposed a close date of 10 days after the initial posting.

Mr. Walther motioned to accept the job description for the Executive Director of APERS as submitted. There was a second from Mr. White and the motion carried.

APPOINT 5-MEMBER SEARCH COMMITTEE:

The Chairman wanted to appoint a 5-member committee to review the applications for this position, in the same fashion as had been done the last time the position was vacant. She appointed a Search Committee comprised of Auditor Lea, Mr. Walther, Secretary Bassett, Mr. Wilson and Mr. Carnahan.

Mr. Walther questioned how many candidates the Chairman expected the committee to bring back to the Board for subsequent interviews and was told three or more.

APPOINT APERS INTERIM EXECUTIVE DIRECTOR:

Ms. Franks noted that it would be prudent to appoint an Interim Director until such time as a new Executive Director could be hired. She recommended that the Trustees appoint Deputy Director Allison Woods and felt that would be leaving the agency in very capable hands during this transition period.

Ms. Lea motioned to appoint Ms. Woods as Interim Director and Mr. Walther seconded. Motion passed.

The next quarterly Board Meeting is scheduled for Wednesday, May 18, 2022, at 9:00 a.m.

GOODBYE TO MR. BAIRD:

Before adjourning the meeting, the Chairman gave a heartfelt thanks to Mr. Baird for all his hard work guiding APERS through the pandemic and getting retirement legislation passed. All the Trustees were grateful for what he had achieved as the agency's Director.
